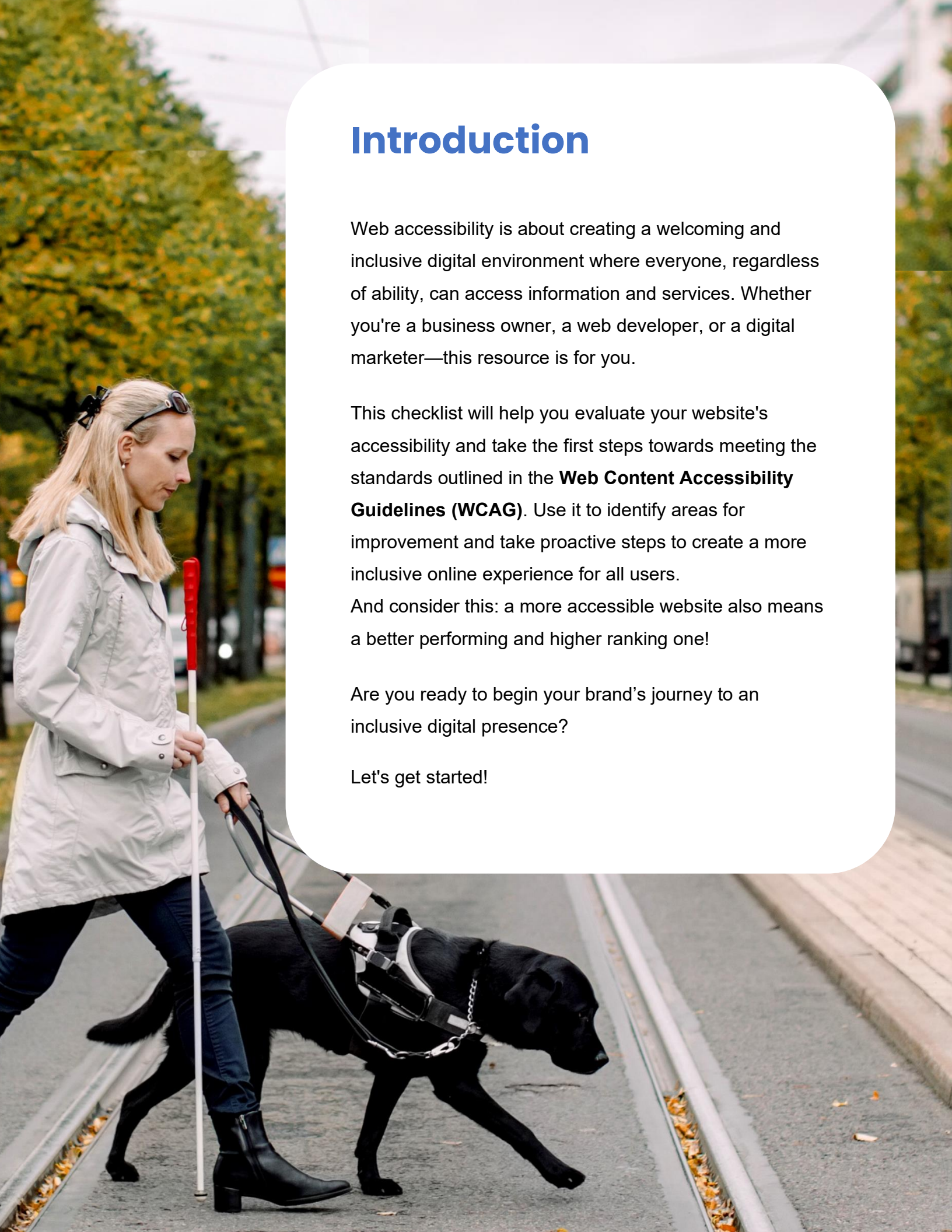

Introduction

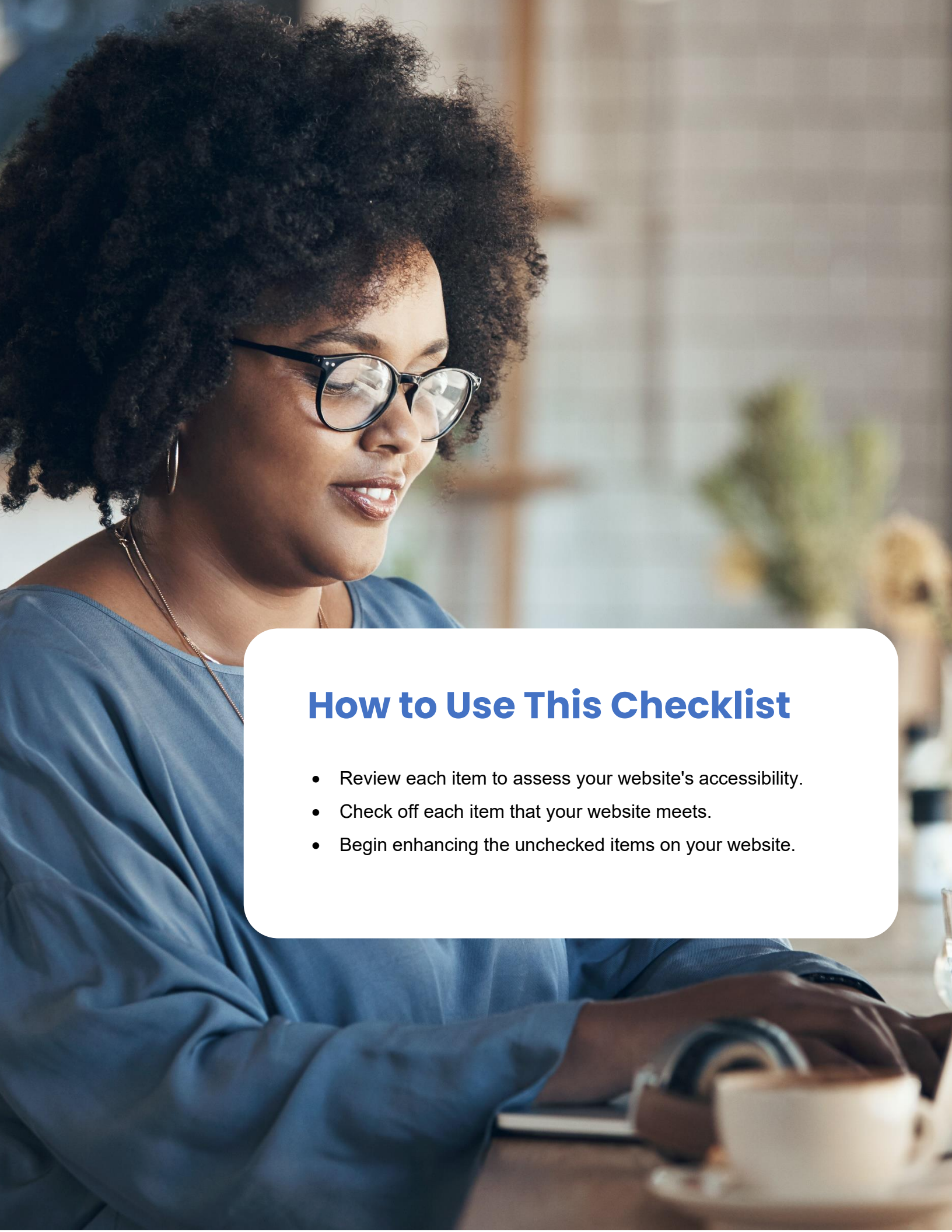

Your Compliance Checklist

1. Perceivable:

- ☐ All functional images and graphics have descriptive alternative text (alt text) that conveys their purpose or content.
- ☐ Videos and multimedia content include captions, transcripts, and audio descriptions.
- ☐ Text content can be resized without loss of content, quality or functionality.
- ☐ Content is clearly visible against the background with sufficient contrast.

2. Operable:

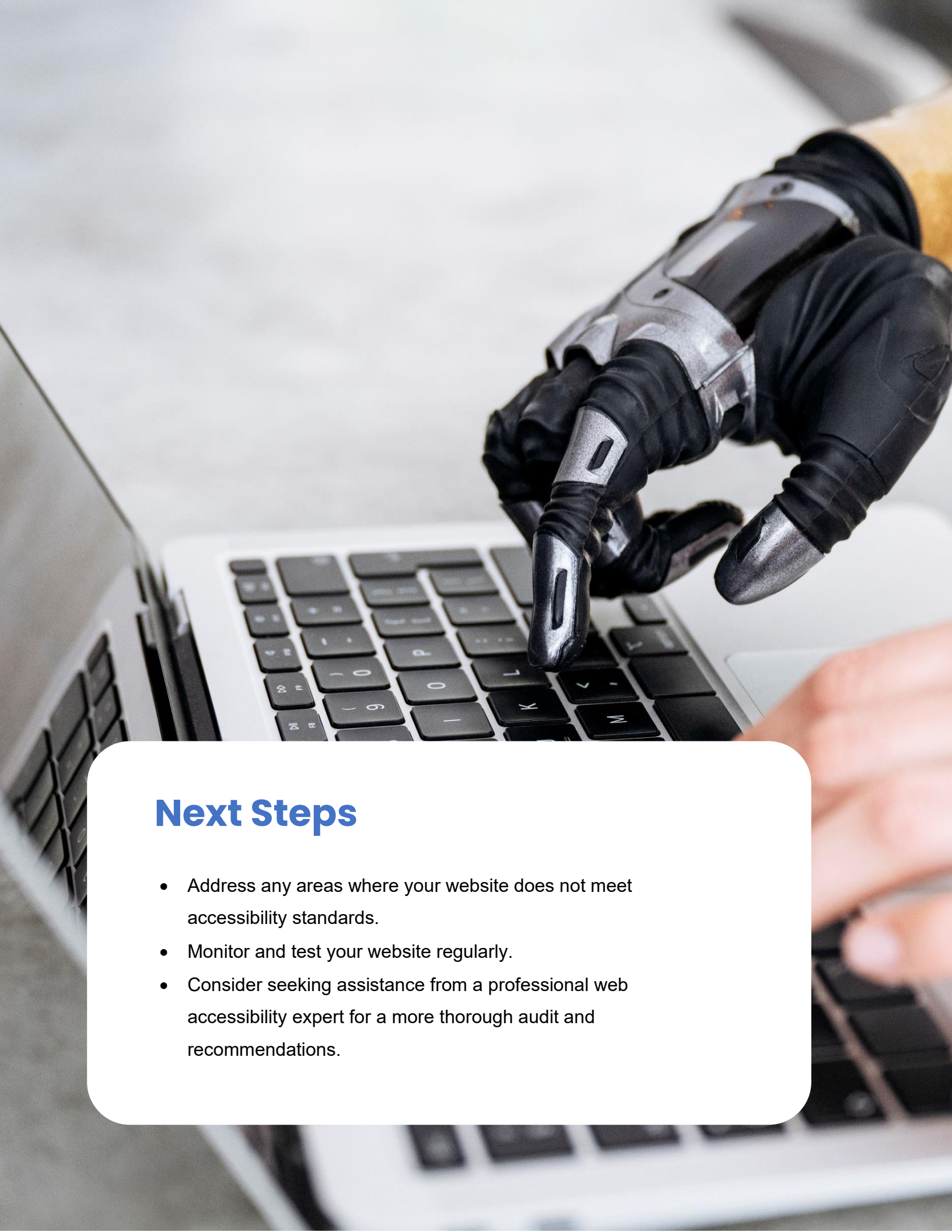
- ☐ All website functionality, including any pop ups, is operable via keyboard navigation.
- ☐ Navigational menus and links are clearly labeled, with distinct cues to differentiate between hover, inactive, and active states.
- ☐ Users are provided with sufficient time to read and interact with content.
- ☐ The website is free from flashing content that may cause seizures or physical reactions.

3. Understandable:

- ☐ Content is consistently presented in a clear and coherent manner.
- ☐ Form fields and interactive elements are properly labeled and provide clear instructions.
- ☐ Error messages are descriptive and provide guidance on how to correct issues.
- ☐ Navigation menus and links are clearly labeled and organized logically.

4. Robust:

- ☐ The website is compatible with a wide range of browsers and screen sizes.
- ☐ Content reflows correctly, text is legible without zooming, and functionality is preserved on smaller screens
- ☐ All links and interactive elements work and load quickly.
- ☐ Accessibility features are regularly tested and maintained.
